PARTICIPANT WAIVER, RELEASE OF LIABILITY & ASSUMPTION OF RISK

In consideration of being permitted to participate in the Ride for RMC, organized by Tactical Tone Memorial Foundation, Inc. ("TTMF"), I acknowledge and agree to the following:

Voluntary Participation & Assumption of Risk

I understand that participation in the Ride for RMC is voluntary and may include traveling in or operating a motor vehicle on public roads as part of an organized vehicle convoy, as well as participating in related event activities.

I understand that motor vehicle travel and participation in a vehicle convoy involve inherent and other risks, including, but not limited to, motor vehicle accidents, collisions, personal injury, property or vehicle damage, actions of other drivers or participants, traffic conditions, road hazards, mechanical failure, and changing weather or road conditions.

I knowingly and voluntarily accept and assume the risks associated with my participation in the Ride for RMC.

Driver & Vehicle Responsibilities

If I operate a vehicle during the Ride for RMC, I represent that:

- I possess a valid driver's license and am legally permitted to operate the vehicle;
- the vehicle I operate is properly registered and insured as required by applicable law;
- the vehicle is in safe operating condition; and
- I am responsible for the safe operation and control of my vehicle throughout the event.

I understand that the Ride for RMC is a **memorial convoy and not a race or speed event**.

I agree to follow the directions of law enforcement officers and authorized Ride for RMC event personnel. Where traffic is being controlled or directed by law enforcement, I will proceed as directed.

At all other times, I remain responsible for safely operating my vehicle in accordance with applicable laws and road conditions.

If I become separated from the convoy, I will not speed, drive recklessly, disregard traffic controls, or otherwise drive unsafely in an attempt to rejoin the convoy.

Passenger Responsibilities

As a passenger, I understand that participation in the Ride for RMC involves travel in a motor vehicle and voluntarily assume the risks associated with such participation.

Drivers are responsible for ensuring that passengers in their vehicles comply with applicable safety requirements, including seat-belt and child-restraint requirements.

Release of Liability

To the fullest extent permitted by law, I release and hold harmless **Tactical Tone Memorial Foundation, Inc., its directors, officers, volunteers, employees, agents, and authorized event personnel** from claims, demands, damages, losses, or liabilities arising from or related to my voluntary participation in the Ride for RMC, including claims involving personal injury, death, property damage, or vehicle damage, except to the extent that such claims cannot legally be waived or released.

I understand that TTMF does not assume responsibility for damage to my vehicle or personal property or for injury, damage, or loss caused by other participants, motorists, road conditions, weather conditions, or other third parties.

Emergency Medical Treatment

In the event of an emergency, I authorize event personnel to contact emergency medical services on my behalf. I understand that TTMF does not provide medical care and that I remain responsible for any medical expenses incurred.

Weather & Event Conditions

I understand that the Ride for RMC is scheduled as a **rain-or-shine event** and that weather, traffic, road, or other conditions may change before or during the event.

I understand that event organizers and/or law enforcement may modify, delay, reroute, suspend, or discontinue any portion of the convoy when reasonably necessary for safety or circumstances beyond the organizers' control.

Photography & Video

I understand that photographs, video, and other recordings may be taken during the Ride for RMC and related activities. I grant TTMF permission to use images or recordings in which I may appear for nonprofit educational, awareness, promotional, fundraising, social-media, and archival purposes without compensation.

Acknowledgment

I certify that I have read and understand this Participant Waiver, Release of Liability & Assumption of Risk. I understand that by agreeing to and/or signing this document, I am voluntarily assuming risks and giving up certain legal rights.

I voluntarily agree to its terms.

Participants under the age of 18 must have this agreement signed by a parent or legal guardian.
